## BOG IT and Data Reporting Committee Information Technology 2/18/25

#### Windows 11 Upgrade

Microsoft has set the end-of-life for Windows 10 for October 2025. After the EOL date, Microsoft will no longer support/update Windows 10 without paying an extra fee to extend service for critical updates only.

The IT department began phasing Windows 10 out over the past several months with the classroom hardware refresh. All new computers and upgraded computers will have the Pierpont image installed, helping with managing the inventory.

The IT department is now beginning a weekly upgrade of all employee/staff devices. The upgrade is planned to take place over the next 6 weeks. Eligible computers will upgrade to Windows 11.

IT will begin refreshing employees' computers in the upcoming budget year starting with the ones that are unable to upgrade to Windows 11, then moving to the oldest devices next.

#### **VR Room Update**

Room 115 has been painted, and power and network connections have been installed. The TVs are mounted on the walls. The storage closet will be used for the networking rack and equipment storage. A fiber run was installed from the new network closet back to the data center to provide connection for the new wireless access points that will run the VR headsets in the room.

There are two large orders that will still need to be purchased, and both have been sent to the Governor to review due to the new Executive Order for all purchases over \$100,000.

The VR Software/VR Headsets will need to go out to RFP once the Governor approves.

The Anotomage VR tables are purchased directly from the vendor and are a sole source.

IT is waiting as close as possible to order the hardware to not allow warranty to elapse with equipment sitting in storage.

#### Banner Self Service 9

The end-of-life for SSB8 is Fall of 2025.

The Institution had a kick-off call with SIG on 1/23/25. The first meeting was for introductions and setting up a timetable for weekly meetings with each affected department.

The areas that will be affected in this upgrade are AR, Student, Finance, and Financial Aid.

This is all front-end and does not upgrade the backend database.
