#### Call to Order

Senate President Findley called the meeting to order at 105 pm in room 216 of the Advanced Technology Center. No virtual meeting option was available per Senate President Findley's request for in-person attendance to this meeting. Quorum was established and attendance was taken using roll call. Order of the day was established on the agenda.

- II. Welcome by the President
  - A. Senate President Findley welcomed everyone to the March meeting.
- III. Minutes of Previous Meeting(s)
  - A. Corrections to / Approval of Feb 9, 2024, Faculty Senate minutes.
  - B. Nick George motioned to approve minutes with corrections. Janet Cole seconded the motion to approve the minutes with corrections. Senate President Findley called the vote which passed unanimously.

# IV. Senate President's Report

- A. President Findley has received reports that not all faculty are receiving email invites to the Faculty Senate meetings. Since the emails have been checked to verify the correct groups were being emailed, there is now a question about whether the Faculty email group is accurate.
  - 1. Senators should check with other faculty members in their respective schools to find out who is not receiving the emails.
  - 2. Anyone not receiving the emails should notify Erika Rush so corrective actions can be taken.
- B. The Strategic Alignment Planning committee met at the Bridgeport Conference Center for a very positive, encouraging, and invigorating meeting. Members of the committee consisted of the President's Council, Alumni, and students. Four pillars of alignment were discussed and include: People, Programs, Partners, and Performance.
  - 1. President Hayward commented that the keyword is *Alignment*.

# V. Administrative Reports

- A. Provost Waide expressed gratitude for the hard work being done by committees.
  - 1. Personnel Committee is working on recommendations.
  - 2. Academic Appeals Board is currently working on an appeal for the first time in 5 years, with Dean Beighley's guidance.
  - 3. General Education Committee has been working on the Assessment of General Education (when, where, how, and who) and redesigning of rubrics for HLC.
  - 4. The Deans have been working on clarifying faculty qualification standards in light of the Department of Education changes that relax requirements for credentialing a faculty member.
    - a. Ironda Campbell commented that WV rates very low in education.
    - b. Examples of requirements across the nation are being reviewed.
  - 5. President Hayward, Provost Waide, and Dale Bradley will be making a trip to Chicago to receive the final HLC report.
  - 6. The search committee for a Director of Career and Corporate Training has scheduled a virtual interview for Mar 21, 2024.
  - 7. Early Registration for Fall 2024 begins Mon Mar 11. Faculty are encouraged to reach out to their advisees or take a whole class to a computer room to register as a group.
    - a. Nick George commented about the need for cleaning up the advising lists on ROAR to remove students who have already graduated.
  - 8. Thanks goes to Vickie Findley for working with the Dean's each week.

- B. President Hayward reminded everyone to tune in to next week's Meet and Confer sessions on Wed Mar 13.
  - 1. The Day of Giving on Thurs Mar 14 includes 50/50 matching in all academic areas. Good progress has already been made to reaching our goal.
  - 2. Vickie Findley mentioned that if a certain number of donations are received in each category, we will be able to see someone get a 'pie in the face'.

### VI. Faculty Representation and Committees

- A. ACF Report: Anthony Anobile (copy available in the TEAMS Mar folder)
  - 1. ACF met on Feb 16, 2024, via TEAMS. Topics discussed include:
    - a. Tenure at CTCs, which will be further discussed at the Provost meeting in May. Anthony is willing to attend if representation is needed. Pierpont currently does have tenure and multi-year contracts.
    - b. HB1105, which would eliminate vaccine requirements for schools.
    - c. Graphic images and pornography in libraries and museums and who is responsible for the materials used.
    - d. Brad Gilbert asked if there is also this much concern for guns in school.
      - i. Since each institution must have their own rules and bylaws, the Safety Committee is working on a draft policy based on other model policies at most CTCs.
      - ii. Provost Waide recommended that the Safety Committee also look at gas/oxygen shut off locations and decide if conceal carry should be restricted on any Pierpont campuses.
    - e. Great Teacher Seminar information has been forwarded to Bryanna Ordiway and the Faculty Development Committee.
    - f. 4 year colleges seem to be getting pressure to offer things that CTCs are already providing, such as micro-credentialling and digital badges.
- B. Board of Governors Report: Susan Coffindaffer (copy available in the TEAMS Mar folder)
  - 1. All BOG committees met in Feb, except the Technology and Data Reporting committee.
    - a. Academic and Student Services Committee, chaired by Tom Cole, was given a report from Provost Waide on enrollment, which is down by 50 after removing non-students. The 2023 Viability index and Faculty Promotions were also discussed.
    - b. The Human Resources and By-Laws Committee, chaired by Tom Cole, discussed revisions to Open Meeting policies and adding 1 holiday. Employee Survey results will be discussed at the next meeting.
    - c. Finance and Administration Committee requested approval of \$40,000 to install HVAC system for culinary academy, which was voted on to send for full Board approval. A possible tuition increase is being considered for 24-25, along with replacement of the Pierpont sign outside the ATC building to create more visibility. A grant was received to finish the ATC 3<sup>rd</sup> floor, with

- renovation in early planning stages and includes flex office space, training areas, and meeting spaces. ATC 216/220 may return to use as industrial training areas.
- d. The Advancement and Public Relations Committee was provided many materials regarding the upcoming Day of Giving. Many matching gifts have been contributed.
- e. The BOG passed revisions to both the Sexual Harassment policy and a repeal of the Open Meetings policy. Executive Session was called to discuss future program development and Deferred Maintenance funds plan.
- f. Let Susan know if you need her to advocate for you.
- g. Melissa White asked about setting up a time to have the Board discuss the 5 year reviews. This will likely occur at the May BOG meeting.
- h. Vickie Findley voiced concerns about the Aviation building and expressed a lack of confidence in the BOG on this topic. The location and ownership of the building seem to be in question, with no movement on plans that were approved in August.
- i. Kari Coffindaffer mentioned that rent was decreased to give FSU a classroom at the Aviation Building.

#### C. SGA Report – Jessica Barker, Student Government Senator

- SGA met on Thurs 3/7/24 to amend the Constitution with updated Vision, Mission, and Values statements and has hopes to complete voting before May graduation.
- 2. SGA has committed to working with student bodies at both campuses.
  - a. Anthony Anobile commented that there are actually 4 campuses: ATC, Caperton, Aviation, and Middletown Commons.
- 3. SGA plans to be involved with marketing using tools such as Instagram and is also bringing awareness to use of student-specific emails.

#### D. Committee Reports

- 1. Personnel Committee Report: Pam Hamilton stated that they are working on a promotion rubric.
- 2. General Studies Report: Rachel Plybon-Beach and Susan Coffindaffer reported that the committee is meeting weekly to revise rubrics to be well-structured and equitable for usage by all programs.
- 3. Media & Learning Report: Melissa White gave an update.
- 4. Faculty Development and Welfare: Rachel Plybon-Beach reported that nominations for awards have been received and discussed, with letters to be sent to recipients.

- 5. Online Learning: Rachel Plybon-Beach provided updates about a productive meeting.
  - Vickie Findley mentioned that they are hoping to find Faculty Senate minutes from 2018 that document the change from Technical Literacy to Digital Literacy.
- 6. Curriculum: Susan Coffindaffer, see new business

#### VII. Old Business

- A. \*\*Senate Constitution changes
  - A motion was made by Melissa White to table the proposed changes to the Senate Constitution until details of the new Shared Governance structure are finalized. Les Boggess seconded the motion. Senate President Findley called the vote which passed unanimously.
- B. Shared Governance
  - 1. Volunteers to help with redeveloping the Faculty Committee structure will be meeting on Mar 14 to continue work.
